Field

Order of Events: (4:30 unless noted)

- Long Jump - Start at 5:00pm (3 Jumps, Top 8 to Finals)
All 3 pits will be in use
 - Boys – 17ft and over (3 Jumps, Top 8 to Finals)
 - Girls – 14ft and over (3 Jumps, Top 8 to Finals)
 - Co-ed – Open pit (3 Jumps, **NO FINALS**)
- Pole vault - Boys followed by Girls (Starting heights: Determined by entry)
- High Jump - Girls followed by Boys (Starting heights: Determined by entry)
- Discus - Boys followed by Girls (3 Throws **NO FINALS**)
- Shot put - Girls followed by Boys (3 Throws **NO FINALS**) Unlimited

SPECIAL NOTES/LIMITATIONS:

- 2 event rule for all Athletes
- 3 Pole Vault Athletes (per gender, per school)
- 2 Discus Athletes Guaranteed (per gender, per school) Boys, before girls
